SUPPLEMENTAL ASSIGNMENT OF PARKING SPACES

Reference is made to a certain Master Deed by Edward T. Moore and J. This assignment is intended to supplement the prior assignments made of both the covered parking spaces and the outdoor parking spaces as set forth in certain Unit Deeds and Amendments to the Master Deed filed prior hereto.
